Mrs. Fletcher moved to approve the agenda, as presented. Mr. Lyons seconded the motion, which passed unanimously.

Resolution No. 43 - Mrs. Fletcher moved to approve the minutes of the regular meeting of April 7, 2014, as presented and the minutes of the special meeting of April 14, 2014, as presented. Mr. Wood seconded the motion, which passed unanimously

Mr. Wood moved to pay the bills as presented. Mrs. Fletcher seconded the motion, which passed unanimously.

# ROBERT BILLINGSLEY PRESENTATION

Resolution No. 45 - Mr. Billingsley, Venango County Historical Society, explained that, presently, there are no World War I monuments in the County honoring those that served. He

proposed displaying a 7-foot doughboy statue of a World War I soldier on one of the cement slabs located in front of the Venango County Courthouse. On the adjoining slab, a granite block monument would be placed listing the names of those Venango County residents that served in the military during World War I. He advised the Council that permission has been given by the County of Venango to use the slabs for this purpose and was requesting permission from the Council. Mr. Marshall moved and Mr. Lyons seconded a motion to grant permission for the placement of the statue and monument. Motion passed unanimously. To send a donation or names of WWI veterans for on the monument, contact the Historical Society at 814.437.2275.

Mr. Billingsley then presented the City with framed photos of General Alexander Hayes and of the Memorial Tablet in Cullman Hall at West Point.

# FIRST READING - BILL NO. 3 - TRAFFIC ORDINANCE FIFTH STREET - Resolution No. 46

Mr. Spaid read Bill No. 3, "Traffic Ordinance Fifth Street," in its entirety, on first reading. Mr. Marshall moved and Mr. Rudegeair seconded a motion to approve on First Reading, Bill No. 3, "Traffic Ordinance Fifth Street." Motion passed unanimously.

### PARADE & PARK REQUESTS - Resolution No. 47

Mr. Lyons moved and Mr. Marshall seconded a motion to approve the following requests:

Motion passed 4-0-2, with Mrs. Fletcher and Mr. Wood, who are members of the 1<sup>st</sup> Presbyterian Church congregation, abstaining from the vote.

#### Manager

- Resolution No. 48 Mrs. Fletcher moved and Mr. Lyons seconded a motion to appoint Mayor Baker as the City's voting member for the Pennsylvania Municipal League and Mr. Rudegeair as alternate. Motion passed unanimously.
- Mr. Gabrys advised the Council that the City's street sweeper had broken and the part necessary to fix it, along with labor and shipping would cost between \$12-15,000. The City has rented a street sweeper from A&H Equipment at a cost of \$2,900/week. He explained the Street Department is running two shifts for street sweeping in the hopes it will be completed by the end of the week. A report from Mr. Ruditis shows the cost of a used 2008 street sweeper would cost \$110,000 with a new sweeper costing in the

\$200,000 range. Council is being asked to consider the matter, which will be discussed further at next month's meeting, and advise what direction they prefer to take in this matter.
